### 2023 R-LINE FLOOD SCHEDULE BEYOND THE POND

Contact the Ditchrider at **541-561-7682** as far in advance as possible if you will not be using your water at the scheduled time in order to avoid spill and flooding. Violation of this rule will cause the District to strictly control water delivery and may result in missing a turn in the rotation schedule.

State Law states that it is the landowner's responsibility to keep irrigation water on their property and not allow tail water to run onto neighboring properties. If you cause damage to another's property due to lack of control of your water, you will be liable.
